# MINISTER ASSURES STEPS TO COMBAT CYBER CRIMES

Parameshwara lauds efforts of police dept in maintaining law & order, directs cops to make all districts drug-free

HIGHLIGHTING the rise in cyber crimes, Home Minister G Parameshwara has assured that measures will be taken to deal with them. He was speaking after inaugurating the new building of Vidyanagar Police Station, constructed under the Karnataka State Police and Hubballi-Dharwad Police Commissioner's jurisdiction here on Tuesday.

Parameshwara noted that India is taking a significant step by forming a special team consisting of DGP, ADGP, IG, and seven SPs to combat cyber crime. Additionally, 43 new cyber police stations have been established and much success has been achieved in recovering funds involved in major cyber crime cases.

Later, speaking during the inauguration of Hubballi Rural Police Station's new building, Parameshwara expressed confidence in making the twin cities drugfree within two years. The reports emphasise Karnataka's efforts in maintaining law and order, while addressing issues like atrocities, cyber crime and drug abuse.

"Some districts have already initiated efforts to become drugfree. Similarly, the police commissioner should take steps to make Hubballi-Dharwad drugfree. In Bengaluru, drugs worth Rs 25 crore, including 14 kg of drugs from a Nigerian woman, were confiscated," he said.

HOME Minister G Parameshwara has said that he will make a request to Chief Minister Siddaramaiah seeking compensation to nine Ayyappa devotees who were seriously injured when a cooking gas (cylinder) exploded at Eshwar temple at Achchavva Nagar Colony, Sainagar, in Hubballi on Monday. He said he will seek the compensation for the injured from the Chief Minister's Relief Fund today itself.

After visiting Karnataka Medical College and Research Institute (KMC&RI) to enquire about the health of the injured, the home minister expressed deep regret over the incident.

"Among the injured, Prakash Baraker has sustained 90% burns. Special care is being provided to him and other injured individuals are also receiving quality treatment as instructed to the medical officials of the institute," he said.

"The Chief Minister is also expected to visit KMC&RI in the coming days to check on the health of the injured. All efforts are being made to provide compensation and an investigation will be conducted into the incident," he added.

For the past few months, the KMC&RI has been functioning under an interim director. Appropriate steps will be taken to appoint a permanent director, the minister said.

Labour and District-In-Charge Minister Santosh Lad highlighted that KMC&RI caters to some of the most critical cases from seven districts of North Karnataka. He praised the institute for functioning as a lifeline for the region and providing excellent treatment. He also noted that significant changes have been brought about within the institute. On this occasion, Karnataka Slum Development Board chairman Abbayya Prasad, deputy commissioner Divya Prabhu, Police Commissioner N. Shashi Kumar and other officials were present.


